2. Booster Bucks, Marla Jedlicka via email

76 families have signed up with Booster Bucks this school year. There are 2 more plastic card orders in November. MANY people are taking advantage of purchasing electronic certificates and reloads. For example, last week, families purchased a little over \$10,000. About \$3,400 was the weekly plastic card order. That's nearly two-thirds in electronic scrip!

Last date to order for rebates to be applied to second Band payment is 11/17. Rebates earned 11/18 and after will be applied to the third payment.

3. Buy-A-Brick, Mark Pfefferman

Income comes in the year prior to installation. We had 7 orders last year and placed 9 bricks (retiring staff). Mark shared an analysis that concluded we should keep prices where they are at.

4. Concessions, Andrea Osterkorn

With the end of the Playoff season, Football Concessions are officially complete. Despite the nasty weather, we were able to bring in about half of the revenue of a regular game at the final playoff (there was no Split the Pot). A suggestion was made to promote credit / debit card sales next year and have a second iPad at the grill.

Thanks again to all of the volunteer parents, many who have covered both the JV and Varsity games this football season. They make all of this possible!

5. Fall Boosters Social, Mollie Buckley

The event went well. We had 54 paid attendees. Whirly Ball went well, we had plenty of food and soft drinks and brewery was well attended and went pretty late. We had 44 tickets turned in for the brewery.
