## I. Welcome and meeting overview;

- II. Call to order- Meeting called to order at 7:05 pm; Monique motioned, Dawn seconded
- **III.** Secretary's report Kristy Riley
  - **a.** Approve January minutes- Dawn moved, Monique seconded to approve, as written
  - **b.** Weinstein award winners will be identified in the spring

## IV. Principal's report – Taff Nielson

- a. Live Life Well week coming up theme- "When it rains, look for rainbows, when it's dark, look for stars"
- b. Winter dance at the end of that week- monitoring tickets to hopefully get enough signed up (Feb 25<sup>th</sup>)
- c. Chess team ended up 44<sup>th</sup> in state
- d. Glenbard Cup- Glenbard Special Olympics Thursday 16<sup>th</sup> at 6:30 in our gym; concessions are all ready to go from Booster's end
- e. Girl's basketball is conference champs; playing tonight
- f. Dance team 7<sup>th</sup> in state
- g. Ryan Kalibec took 46th in state for bowling
- h. Coach Hartke is winningest coach in GBS history
- i. Music groups going to Disney in March
- j. Boys and Girls basketball will be hosting sectionals- should be packed
- k. Working on distinguished alumni wall
- Monique asked about graduation plans- will be indoor; 6 tickets/student likely; choir and band will be performing; senior special edition coming soon with answers to some of these questions

#### V. Committee and Event Reports – events upcoming through March

- a. Winter Social- post report- Stephanie Herlein
  - i. Monique reported that as of now, revenue came in about \$4665 with expenses at about \$462, so we should have a good result
  - ii. We have more money from this event this year than last year
  - iii. Stephanie and husband in to do it again next year!!
- b. Wine Bingo- planning discussion- Melissa Calfo
  - i. Melissa emailed Nikki- she would like to have something other than Wine Bingo to raise funds for post prom/senior celebration
    - 1. Nikki asked how we feel about another fundraising event in the spring; we just had Winter Social (proceeds will go to post prom

- and senior celebration); will have Floral Symphony (asking for donations, too); will have Golf outing, (asking for donations)
- **2.** We need money for post prom and senior celebration, but are we oversaturating things?
- **3.** Proposed Whirley Ball for parents and/or students; if have students, no alcohol can be available
- **4.** Taff- used to do a dodgeball tournament with Key club to raise money for Wounded Warriors GBW vs GBS cross-town tournament- huge success (\$10,000); could we do something like this but keep proceeds for Boosters? Low cost, big turnout, big \$; all grades, teachers/staff participated, etc.
- ii. Last year, Wine Bingo brought in about \$3400
- iii. Monique said we'll be soliciting (and getting) donations for the senior celebration (got \$5000 last year- fully funded the celebration), so we should be in decent shape even without Wine Bingo for the senior celebration and post prom; plus we don't have to pay for the turf
- c. Concessions Abida and Scott Kokoszka
  - i. Taff and Abida working on getting shelves installed in the inside concession stand, moving display board, removing old equipment hopefully by spring break
  - **ii.** Sectionals- do we know what volume will be to prepare inventory? Taff will talk with Tim Carlson and let Abida know a general ballpark
  - iii. Girls track is kicking off soon- working on that staffing
  - iv. We have had some issues with money; Courtney will work to get Spring team parents;
  - v. Next year, Monique proposes that if a team cannot provide a team parent, they cannot staff the stand; money is missing, bad controls over the cash/accounting
- **d.** Raider wear Ayesha Ahmed- nothing to share
- e. Plant sale- Tara Arick- sales likely done by next meeting; Dawn and Tara working on the website; April 29 pick up; sales live March 1; will be a flyer at Floral Symphony, too; early bird and last-minute discounts (10% and 5%); share the info with as many people as possible; may do a "win a flat" sponsorship (\$10 per flat- Tara will ask folks to do this); would like to get this on the electric marquee (email Taff and Maria); prices adjusted only slightly this year
- f. Floral Symphony- Suzie Milano- Dawn reports that we have 95 tickets sold for \$1895 online orders; may be checks and such coming in; Dawn asked if Tara could promote the Floral Symphony at Glen Crest and Dawn will reach out to the Music Boosters there,too; Can go into the Principal's newsletter, too;
- g. Post Prom- Melissa Calfo/Teara Moore- We have not gotten an update from Melissa nor Teara in a while; we need an update on the location and bussing details; Nikki will reach out to ask for update from Melissa; Taff will work with GBS folks to share his experiences running post proms in the past
- h. Golf Outing- Mario Castillo- see 2<sup>nd</sup> VP report
