- II. Welcome / Called to order at 7:08pm
 - a. Dawn motioned to begin meeting, seconded by Kristy
- III. Secretary's report Kristy Riley
 - a. Motion to approve April meeting minutes- Dawn, seconded by Monique; approved, as written
- IV. Principal's report- Jessica Santee

College send-off today- those who will play at college level and parents came for a ceremony today

The bathrooms near the football stadium will require expensive, massive repairs (ripping up parking lot to the theater) due to destroyed pipes; will try to tackle it section by section this summer; Abruzzo will also be resurfaced this summer

V. Committee and Event Reports – events upcoming through June

- a. Plant Sale Final Report Tara Arick
 - Pick-up went well, good volunteers, only had to deliver a couple of orders Christina Noellsch reached out to Tara and offered to be co-chair next year Doesn't know final numbers; sold a lot on the same day and has sold some since
 - Revenue was \$11,000+, cost ~\$5000, so net was about \$6000- we exceeded

- c. Post Prom Melissa Calfo, Teara Moore
 - The GBS team is figuring things out; next year will be more organized and know what to ask at the correct times (parking, permissions, attendance, etc.)

 Prudential (security) is on-board
 - Volunteers- do we have enough? When will volunteers get their assignments?

100 to post-prom, so need 1 volunteer per 25 kids; right now, have Melissa, Teara, Christine Foster, Jessica Santee, Marina Kosak Nikki has talked with Melissa about assignments, volunteers, etc. and will follow-up with her this week

d. Senior Fun Fest – Lynn Lullo and Tessa Cirrachi, Co-Chairs Lynn sent a letter tonight to the board; Dawn read it to the attendees Almost filled with volunteers, but need more for clean-up Jessica sent announcement to seniors today and the dunk-tank sign-up to faculty/staff

Kids are allowed to leave after 12:30, but after 1 last year, most kids started to get yearbooks and caps and gowns so the crowd will be thinner later in the afternoon

e. Golf Outing - Mario Castillo

Mario has been communicating a lot lately

Dawn has asked Mario to figure out volunteers- #s, where, ages... and will set-up as SUG for him

We have 2 paying sponsors and 2 who gave away items

Not a lot of golfers as of yet nor silent auction items

Dawn and Jessica will put messaging out next week- need to get through the week and then hit the messaging hard

GBS sent letters to numerous businesses asking for donations

f. Concessions – Abida and Scott

Wrapping up the year

Will need training videos and new equipment over the summer- coolers are leased through Pepsi; need a food/pizza warmer

Need to rearrange outside stand

Taff will help with training videos

g. Raiderwear- Ayesha- nothing to add; she just looked for an order but there is nothing in the closet

VI. President – Nikki Dawson

- a. Vote in Board officers for 2023/2024 through 2024/2025 term
 - i. Tara Arick for 1st Vice President Kristy made the motion, Dawn seconded; The board unanimously approved her for the position!
- b. Additional needs
 - i. Treasurer no one yet identified
 - ii. Support for VP 2

Nikki will be sending an email with details about what the positions (esp. treasurer) entail and will frame it as a 2-person position (treasurer) and 1-person to support VP 2, if possible;
Dawn and Kristy can work together this next year to handle the VP 2 position, but the next year, we definitely need 2 people
We need more than Board positions, we need chairs and volunteers so that it doesn't feel so big and overwhelming and so that the same people don't have to keep doing the lift
Board members are not ad-hoc committee chairs, but do a lot of the work

Monique- Boosters may have become too unwieldy... maybe pair down what we do and raise money for (teacher appreciation, scholarships, senior celebrations); update/change/reduce our mission and footprint

Maybe in a few years the school takes over concessions and makes all the money (maybe it will become a club where students learn to run businesses); lots of great ideas

East, West, and North have multiple parent clubs; we only have Boosters

VII. Treasurer – Monique Wilharm

a. Financial report disseminated

Total of \$420 in donations for staff appreciation Concessions projecting to come out with \$37,000 in profit Restaurant nights- only about \$838 in profit, nothing since March Paid up on post-prm

Projects end-of-year \$19,000 in profit; Boosters keeps about \$5000 for seed for upcoming year

Post-prom estimates: funding \$12,500; costs \$19,500; gap of \$4,994.68 Re: Golf- 72 golfer minimum; budgeted \$9800; only 20 golfers registered right now; have \$4000 so far from golf; will pay out \$9800 minimum (before plaques, prizes, etc.); if we don't sell any more golfers, we will have a \$5700 defecit that comes out of \$19,000 end-of-year profit margin Mario needs to stop spending any money until we get more golfers

- b. YE Close: Activity Passes Dawn coordinates with D87 and submits a check request; Dawn has to return unused passes to D87 with the check request; Dawn has receipts for some expenses to turn into Monique
- c. YE Close: Concessions Rob needs to submit Pepsi check request
- **d.** YE Close: Booster Bucks Lynn needs to submit check request for final payment to GBS and Lynn needs to send report to GBS re: where the \$ is to go
- **e.** YE Close: Floral Symphony Mr. Govertsen needs to get all check requests submitted and then send me a check request to receive the proceeds
- **f.** YE Close: Concessions Monique will work with Mr. Carlson on Spring Staffing and Hospitality tickets
- g. Will be meeting with Nancy to discuss Raiderwear for next year
